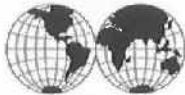

Re: Application for Swimwear Approval – Date of application
30 September 2007

Dear Mr Matthews,

We would like to inform you that the application, referred to above, was examined by the ad hoc Commission during its session of 5th October 2007.

We are pleased to inform you that said application has been broadly accepted. The swimwear model in relation to which the request for the approval has been submitted have been declared compliant with the FINA Requirements for Swimwear Approval ("FRSA") and, upon the Commission's positive recommendation, said swimwear items have been duly approved by the FINA Executive.

In accordance with the FRSA, the present formal approval is subject to the following conditions:

1. This approval shall be valid for 4 years (approval cycle), i.e. until the end of the second full month following the next General Congress due to take place in 2009.
2. If the approved swimwear continues to be used after the end of this approval cycle, the present approval shall be submitted for reconfirmation for the next approval cycle, in accordance with the FRSA.

Any such modification shall require a new application for swimwear approval, in accordance with the procedure described in clause 4 FRSA.
4. The applicant is allowed to indicate the present approval in the product documentation and/or on the product packaging relating to the approved swimwear, as well as on any such swimwear label, by the words "approved by FINA" in the normal font script and size used in the concerned text. If used in isolation, the above words shall not be prominent. For the avoidance of doubt, usage of the FINA Logo or other trademarks of FINA is not permitted in any way.

In application of Clause 4.5 FRSA, the administrative costs relating to your application amount to **1500.- €** Please find enclosed the relevant invoices.
